## 2011 Concession Booth Agreement

The Taos Mountain Balloon Rally Association and \_\_\_\_\_  
(Vendor) agree as follows:

TMBRA shall provide a space no larger than 20' X 10' in which VENDOR may erect a temporary sales or park a self-contained mobile unit to allow VENDOR to conduct his/her business during the 29<sup>th</sup> Annual Taos Mountain Balloon Rally.

The dates for the 29<sup>th</sup> Annual Taos Mountain Balloon Rally during which VENDOR may conduct business are October 28 – 30, 2011.

VENDOR may set-up his/her unit on Thursday October 27, 2011 and is responsible for their own security.

VENDOR shall be responsible for his/her own insurance and all necessary governmental permits, whether town or county of Taos, and shall submit such proof of insurance and governmental permits to TMBRA upon signing of this agreement.

VENDOR shall be responsible for providing any electricity (generator) and lights necessary to engage in his/her business during the Rally period.

VENDOR shall dismantle and clean the area of his/her booth on Sunday afternoon, October 30, 2011 and shall leave area free of trash, lumber, nails, etc. before VENDOR vacates the premises subject to approval of an appointed TMBRA official.

Booth fee for this event shall be \$50/day, payable to TMBRA on or before October 15, 2011. Checks, Proof of Insurance, and this application shall be given to a Board member or be mailed to the address above.
